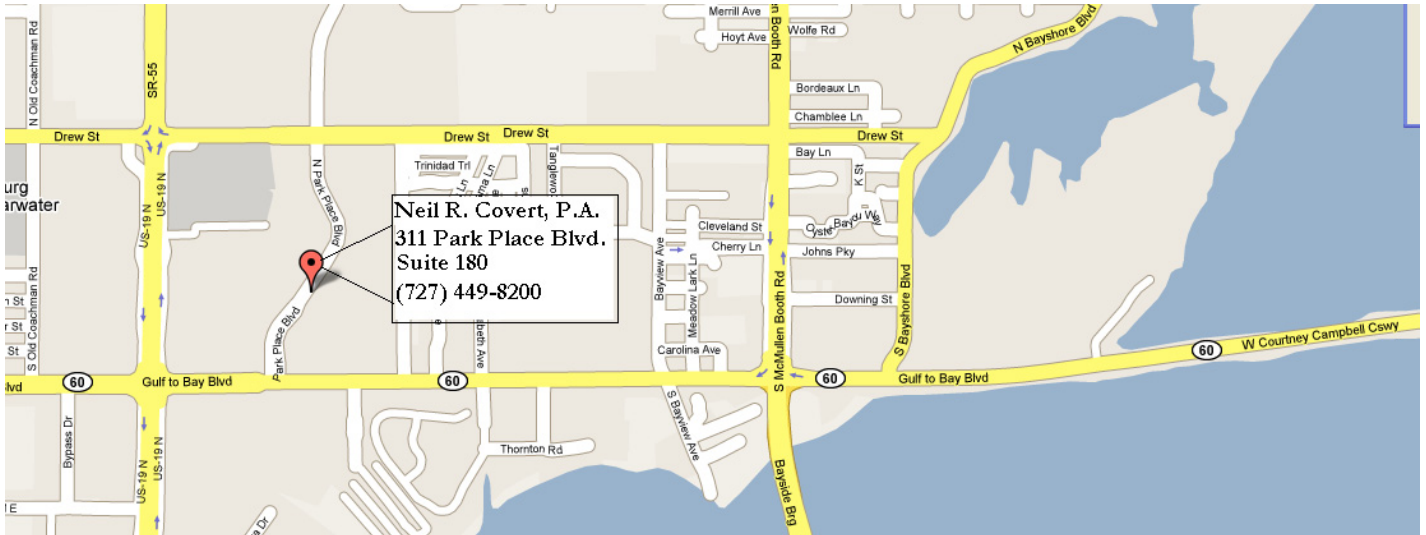

**From Downtown Clearwater, Clearwater Beach and Belleair**

Take Gulf-to-Bay Blvd. east towards U.S. 19. Continue on Gulf-to-Bay past U.S. 19 (you will go under the overpass). Please get into the left lane when possible and turn left at the second traffic light after 19. This will be Park Place Blvd. Turn right at the second street into our office parking lot.

**From Dunedin, Palm Harbor, Tarpon Springs and New Port Richey**

Take U.S. 19 southbound into Clearwater. Exit at the Drew Street/Gulf-to-Bay exit, then proceed through the first light, turning left at Gulf to Bay Blvd. Use the left most lane of the two turn lanes. Please stay in the left lane on Gulf-to-Bay. Turn left at the second traffic signal, which is Park Place Blvd. Turn right at the second street into our parking lot. *(Alternate route using McMullen Booth Rd/ East Lake Rd: Exit McMullen Booth before reaching the Bayside Bridge, turn right onto Gulf-to-Bay. Then turn right at the third traffic light onto Park Place Blvd. Turn right at the second street into parking lot.)*

**From St. Petersburg, Sarasota and Bradenton**

Take I-275 North to the exit for **state road 688 Roosevelt Blvd./St. Pete-Clearwater Airport exit**. Continue on exit ramp following the left fork of the ramp. Merge onto Roosevelt Blvd. and then merge onto **Ulmerton Road**. Stay in the right two lanes and then take the right exit onto **686 Roosevelt Blvd**. You will pass the St. Pete/Clearwater Airport. Make a right onto the **Bayside Bridge northbound**. Take the first exit off the bridge, which is the exit for **Gulf-to-Bay(S.R. 60)**. Turn left at the bottom of the exit ramp onto Gulf-to-Bay (S.R. 60). Turn right at the third traffic signal onto Park Place Blvd and then turn right at the second street into parking lot.

**From Tampa, Lakeland and Orlando**

Take I-4 West to I-275 South. Continue on I-275 South past downtown Tampa and take the Tampa Int'l Airport/Clearwater/SR 60 exit. Continue on Memorial Highway past the exit for Tampa International. Please merge into one of the left lanes so you may turn left onto the Courtney Campbell Causeway (S.R. 60). Take the causeway across the bay into Clearwater. Go past McMullen Booth Rd./Bayside Bridge (an overpass). Turn right at the third traffic signal (approx 1 mile after overpass), which is Park Place Blvd. Turn right at the second street into our office parking lot.
